A member's Boating Seniority Date is the date the applicant or member is accepted as a Boating Member by the Club's Executive Board. Members who do not have a Boating Seniority Date will not be considered when slip assignments are made.

The Club's Executive Board has no obligation to justify or to explain any failure of the Club to accept an applicant for membership.
